ASSUMPTION OF RISK I KNOW THAT RUNNING/WALKING IN THE 2023 SASKATCHEWAN MARATHON THAT IS BEING ORGANIZED AS A LIVE EVENT IN THE CITY OF SASKATOON OR A VIRTUAL ACTIVITY WHERE I RUN ON MY OWN, AT A DATE AND TIME OF MY CHOOSING BETWEEN MAY 28 AND JUNE 28, 2023, IN A LOCATION OF MY CHOOSING, WHICH WILL NOT HAVE ANY SUPPORT OR SECURITY MEASURES IN PLACE BY THE SASKATOON ROAD RUNNERS ASSOCIATION, IS A POTENTIALLY HAZARDOUS ACTIVITY, WHICH COULD RESULT IN INJURY OR DEATH. I acknowledge that I am participating in the 2023 Saskatchewan Marathon of my own free will and at my own personal risk. I will not participate in the 2023 Saskatchewan Marathon unless I am medically able and properly trained, and by my signature, I certify that I am medically able to perform the 2023 Saskatchewan Marathon, and am in good health, and I am properly trained. I further agree to abide by the Canada's Public Health recommendations for the prevention of the spread of COVID19 and attest to having read the guidance [here](#).

**If I chose to run/walk the virtual race in my community**, I will check with my local health department for COVID recommendations specific to your location. I attest that if my community has a shelter in place order, that I will only participate virtually by using a personal treadmill, and I will not run outside in the community during the duration of a shelter in place order. I agree to follow all pedestrian safety ordinances including running/walking on a sidewalk where available and not on the road. I agree to follow the rules of the road if no sidewalk or multi-use trail is available, and I will run against oncoming traffic and not with traffic. I assume all risks to me associated with running/walking on my own as part of the 2023 Saskatchewan Marathon, including but not limited to: falls, contact with other pedestrians, the effects of the weather, including high heat and/or humidity, traffic and the conditions of the road or trail, all such risks being known or unknown and appreciated by me when out running/walking on my own without any type of support from local officials or event organizers

**If I choose to run/walk the live race on May 28, 2023, in Saskatoon**, I agree to abide by any decision of a race official relative to any aspect of my participation, including the right of any official to deny or suspend my participation for any reason whatsoever.

I attest that I have read the rules of the 2023 Saskatchewan Marathon including the terms in this waiver and agree to abide by them. Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, for myself and anyone entitled to act on my behalf, waive and release the 2023 Saskatchewan Marathon, the Saskatoon Road Runners Association, all event sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation in the 2023 Saskatchewan Marathon, and waive my ability to bring any legal action against the entities outlined in this waiver as I am voluntarily electing to run as part of the 2023 Saskatchewan Marathon.

OTHER AGREEMENTS I grant permission to the 2023 Saskatchewan Marathon to use my photographs which I may share online as part of the event, personal data provided during registration and post-event reporting, video or audio recordings, or any other record of this event for any legitimate purpose. I understand that this event does not provide for refunds in the event of a cancellation, and by signing this waiver, I consent that I am not entitled to a refund if I am unable to run. I ACKNOWLEDGE THAT I HAVE READ THIS WAIVER AGREEMENT AND FULLY UNDERSTAND ITS TERMS. I ACKNOWLEDGE THAT I AM ENTERING INTO THIS AGREEMENT VOLUNTARILY, AND I INTEND FOR IT TO BE BINDING ON MYSELF, MY HEIRS, EXECUTORS, ADMINISTRATORS, AND REPRESENTATIVES.
